2 WHAT'S BEEN HAPPENING?

Evolution of the project and on-going workstreams

ACQUISITION

Enerfín in a 50/50 consortium with ICA Partners (one of Australia's leading advisory firms) acquired the Woolsthorpe Wind Farm project from Wind Farm Developments (WFD) in September 2018, to finalise the planning, financing and ultimately construction of the renewable energy facility. After which we will be a long term holder of the asset.

POWER PURCHASE AGREEMENT

In December 2018 a Power Purchase Agreement (PPA) was signed for 100% of the power generated by the Woolsthorpe Wind Farm with Snowy Hydro Ltd. being the off-taker.

CONSTRUCTION CONTRACT

At the start on 2019, Enerfín and ICA Partners worked on the selection process for a EPC (Engineering, Procurement, Construction) contractor to carry out the full scope of works needed to build the Woolsthorpe Wind Farm. The selected contractor was Siemens Gamesa Renewable Energy (SGRE).

Siemens Gamesa is a leading supplier of wind power solutions to customers all over the globe. A key player and innovative pioneer in the renewable energy sector, they have installed products and technology in more than 90 countries, with a total capacity base of over 89 GW and 23,000 employees.

DEVELOPMENT

Plans required to satisfy the Planning Permit were lodged in June 2019 to the Department of Energy, Land, Water and Planning (DELWP) and were endorsed by the Minister for Planning on the 18th October 2019. Due to the delay to site mobilization and start of construction, some documents will have to be reviewed to make sure all the conditions from local and state government entities are being met. All endorsed documents can be found on the project's website under "Overview and Useful Links".

CONNECTION


As the developers and owners of the Woolsthorpe Wind Farm, we need to have complete certainty that it will connect without compromising the stability of the grid and availability of the electricity supply. For this reason, the connection process has required significant engineering and due diligence work. Whilst we have made significant progress to date, it is always the last 10% which is the hardest.

We need to ensure that Powercor, as the local distribution utility, and AEMO (Australian Energy Market Operator) are satisfied with the connection solution proposed. It is worth noting that currently AEMO are stuggling with grid stability issues in Western Victoria, and as a result have halted progressing connection application until they have clarity on the issue. The Woolsthorpe Wind Farm is caught up in this issue however we will continue to engage with AEMO to confirm when our connection application will be assessed. This is an unfortunate situation but something we are confident we can manage.

CONSTRUCTION


Site mobilisation was scheduled for early November 2019 but with the connection work-stream delayed as noted above we've had to push back construction until we have fully de-risked the the connection and have sight on our Offer to Connect.

We are investing all of our resources and efforts to achieve a site mobilisation date by October of 2020 but given the current status of the connection workstream, this is an optimistic outlook. We will update this information as we get more clarity on the subject.

4 UPCOMING ACTIVITIES

COMMUNITY MEETING (DATE TO BE CONFIRMED)

5 FREQUENTLY ASKED QUESTIONS

IS WIND ENERGY GOOD FOR THE ECONOMY?

Wind energy avoids the external or societal costs associated with conventional resources, namely, the trade deficit from importing foreign oil and other fuels, the health and environmental costs of pollution, and the cost of depleted resources. Wind energy is a domestic, reliable resource that provides more jobs per dollar invested than any other energy technology - more than five times that from coal or nuclear power, according to the U.S. Department of Energy.

WHAT ARE THE GENERAL BENEFITS OF WIND ENERGY?

Wind turbines have many advantages. Wind energy is 100% clean energy that is free from all political, ethical, economic and environmentally damaging problems inherent in coal, oil, gas or nuclear power. Wind energy has none of the major drawbacks inherent in other forms of electricity: no geopolitical risks, no foreign energy dependence, no fuel risk, no exploration, no refineries, no pipelines, no depletion of raw materials and no radioactive waste and virtually no carbon emissions.

DO WIND TURBINES HARM WILDLIFE?

Wind farms are always subject to an Environmental Impact Assessment to ensure that their potential effect on the immediate surroundings, including fauna and flora, are carefully considered before construction is allowed to start. Deaths from birds flying into wind turbines represent only a tiny fraction of those caused by other human-related sources such as vehicles and buildings. It has been estimated that wind turbines in the US cause the direct deaths of only 0.01-0.02% of all of the birds killed annually by collisions with man-made structures and activities.

6 COVID-19 UPDATE

The Woolsthorpe Wind Farm Team will act upon and manage any future directions from the Victorian or Australian Governments. The health and well being of our employees, contractors and the broader community is of highest importance.

Protecting yourself and others from COVID-19

- Regularly and thoroughly clean your hands with an alcohol-based hand rub or wash them with soap and water.
- Maintain at least 1.5 metre (5 feet) distance between yourself and others.
